## Extension of the period for relaxation of evaluation criteria and waive off arrears payments for CIDA registered contractors

In relation to the procedures for Registration, Grading, and Monitoring of National Construction Contractors, approval was granted at the Management Board meeting held on 2025.01.22 to extend the implementation of the following concessions for contractors registered with CIDA.

Accordingly, the following concessions have been granted:

- 1. Waive off arrears payments for three years for contractors from C4 to C9 who have not renewed / extended their registration after 2022.12.31. (The concession period has been extended until 2025.03.31.)
- 2. Opportunity for contractors from C3, C2, and C1 to pay three years of arrears in two installments within six months.
- 3. Opportunity to submit applications before 2025 March 31, as the concession period is valid for three months.
- 4. The usual application evaluation procedures will also apply during the concession period.
- 5. Arrangements to charge fees according to the prevailing rates for arrears exceeding three years.
- 6. The concessions mentioned under item 2 will be effective from the date the registration committee approves the specific registration for the applications submitted by the respective contractor.

Relaxation of evaluation criteria - This has been extended until 2025.12.31.
